- a. Hypo: John previously owed Mary \$450 per month. The court reduced the child support to \$250 per month effective June 15, 2024. As of May 31, 2024, John owed \$5000 in principal arrears and \$350 in interest. Since June 1, 2024, John has made one support payment in December 2024 in the amount of \$500.00.
- 3. Handle a Complex Arrearage Case Where Support Amounts Vary Between the Effective Date and the Arrears Calculation Date
 - a. Hypo: John previously owed Mary \$450 per month. The court reduced the child support to \$250 per month effective June 15, 2024. And on August 1, 2024, increased the support to \$375 due to a change in daycare. As of May 31, 2024, John owed \$5000 in principal arrears and \$350 in interest. Since June 1, 2024, John has made one support payment in December 2024 in the amount of \$500.00.

Complex Guidelines
